Employee benefits are an extremely important part of your compensation package. Mediant Health Resources prides itself on providing our employees with a comprehensive and competitive benefits package. Mediant Health Resources is pleased to offer all full-time, salaried employees the chance to enroll in our benefit plans, which renew on December 1st each year.

It is important that you make your choices carefully since you cannot change your elections during the year **unless** you have a qualified change in family status.

Examples of a qualifying event are:

Marriage, divorce, birth or adoption, death of a dependent, change in your spouse's employment, loss of coverage by a spouse (you have 30 days to notify HR); **OR**

Loss of eligibility under Medicaid or state child health plan or change in eligibility for a premium assistance subsidy under Medicaid or state child health plan (you have 60 days to notify HR)

Your eligible dependents are defined as your legal spouse and your children (to the end of the month that they turn age 26).

After careful consideration we will be renewing our medical benefits with United Healthcare for the 2021 – 2022 plan year. Mediant Health Resources pays a substantial portion of the Medical insurance premium for you and your dependents. We are happy to share with you that again for the 2021 – 2022 plan year your medical premium deductions will remain the same. You are responsible to pay for the remainder of the cost to cover your family members for medical. The medical deductions are taken out of your paycheck pre-tax, so that you can save money on your taxes by getting your insurance through work.

The summary in this newsletter is just an overview of the medical plan, so please make sure to read the full plan details in the documents provided by the United Healthcare.
